Article counts refer to publications from selected journals and conference papers in S&E from Scopus. Articles are classified by their year of publication and are assigned to a region, country, or economy on the basis of the institutional address(es) of author(s) listed in the article. Articles are credited either on a fractional- or whole-count basis. Fractional counts of articles are those produced by authors from different countries, where each country receives fractional credit on the basis of the proportion of its participating authors. For the fractional-count basis, the sum of the regions, countries, or economies may not add to the world total because of rounding. In whole counting, each region, country, or economy with a collaborating author on an article is credited with one count. The sum of the whole count for regions, countries, or economies does not add to the world total because of multiple counts of coauthored publications. Some publications have incomplete address information for coauthored publications in the Scopus database. The unassigned category count is the sum of fractional or whole counts for publications that cannot be assigned to a region, country, or economy.
